## **Sweepstakes Rules**

### 5. How to Enter

#### 7. Winner Notification

The potential winners will be notified by Social Media ONLY. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. #### 9. General Conditions
